Pursuant to Important Notice <u>a8875</u> dated July 23, 2020, National Securities Clearing Corporation (NSCC) will implement a **revised Saturday processing schedule** for the Mutual Fund Networking service effective **Saturday, January 16, 2021.**

The cutoff time to submit files (mainframe and web) will be shortened and changed to 1:00 PM ET for those services which currently have a later cutoff time. Please note, although the 1:00 PM ET cutoff is earlier than the 2:00 PM ET previously communicated in Important Notice a8875, we anticipate minimal impact to Saturday activity processing as our extensive analysis indicated over 99% of Saturday activity was received by 1:00 PM ET.

Please refer to the Appendix for the revised schedule changes. Additional details for multi-cycle product schedule changes are available in the updated processing schedule, which has been posted to the DTCC Learning Center.

Important Notes:

- The Networking Fund Conversions will have an earlier cutoff time (changed from 12:00 PM to 11:00 AM ET) as Fund Conversion processing must complete before Broker Conversion processing commences.
- The Payment aXis Saturday schedule is not impacted and remains unchanged.
- Networking and Payment aXis files submitted after 2:00 PM ET on Saturday must have the next business day's date in the DataTrak header or they will be rejected.
- The PSE test environment does not run on Saturday's and is not impacted.
- This schedule change does not impact the Reg SCI weekend processing schedule, which remains unchanged. Important Notices of Reg SCI schedule changes are distributed, with reminders sent prior to each Reg SCI test. For the current schedule, please see <u>Important Notice a8852</u>.
