OVERVIEW

DTCC Money Market Kinetics provides daily or intraday anonymized Commercial Paper (CP) and Institutional Certificates of Deposit (CD) settlement transactions data (excluding IPA to dealer), enhancing market analysis.

Each day DTCC's depository subsidiary, Depository Trust Company (DTC), processes and settles approximately \$300 billion in new issuances, maturities and turnaround deliver orders for CP and Institutional CDs, generating detail-rich, multi-field transaction records.


HOW IT WORKS

DTCC Money Market Kinetics is derived from DTC's settled dealer turnarounds and directly placed paper transactions.

DTCC's CP and institutional CD data is derived from DTCC settled dealer turnarounds and directly placed paper transactions.

DELIVERY

- ➤ End of day: Approximately 5:10 p.m. ET, containing all transactions for the day.
- ➤ Intra-day: Every half hour from 8:10 a.m. to 5:10 p.m. ET cumulative files.
