## **SUPPLEMENT TO TRADE INFORMATION WAREHOUSE SYSTEM USER AGREEMENT**

*SETTLEMENT CUSTODIAN*

The undersigned has executed a User Agreement (the “User Agreement”) providing for its participation in the Trade Information Warehouse (the “System”) operated by DTCC Deriv/SERV LLC and DTCC Derivatives Repository Plc (each, a “Company” and collectively, the “Companies”). By executing that User Agreement, the undersigned and each Company agreed to be bound by the Operating Procedures of each respective Company, the Trade Information Warehouse (collectively, the “Operating Procedures”) and the Applicable Publications (as defined in the Operating Procedures), as each may be amended, supplemented or modified from time to time, beginning as of the date entered below (the “Effective Date”).

The undersigned authorizes the relevant Custodian listed on the Central Settlement Facility Settlement Service Request Form (the “Service Provider”) to access the undersigned’s information in the System via the Service Provider’s Computer-to-Computer Link or Web Front End (as each is defined in the Operating Procedures). The Service Provider’s access on behalf of the undersigned will be limited to those services selected in the Service Provider Authorization Elections by Product form attached hereto, as amended from time to time by the undersigned and valid upon acceptance by the Companies. In addition, the undersigned or its agents, including the Service Provider, may access the System’s Web Front End (as defined in the Operating Procedures) by means of digital certificate(s) and password(s), or other secure identifiers, assigned to the Service Provider or its affiliates. The undersigned acknowledges that Service Provider’s Computer-to-Computer Links, as well as the digital certificates, or other secure identifiers, assigned to it, may be used by the Service Provider to access the System on behalf of other Users (as defined in the Operating Procedures), who may not be affiliated with the undersigned.

In light of the foregoing, the undersigned specifically agrees that the Companies shall have no liability for any failure of the Service Provider to act upon such messages or reports, or otherwise to properly use the System, either through Computer-to-Computer Links or the Web Front End.

It is understood and agreed that this document shall constitute a separate agreement between the Companies and each fund/entity that is listed in the current Central Settlement Facility Settlement Service Request Form, as amended from time to time (“SSRF”), as if each such fund/entity has executed a separate document naming only itself as the undersigned, and that no fund/entity that is listed in the SSRF shall have any liability under this document for the obligations of any other fund/entity that is listed in the SSRF solely by reason of being listed in the SSRF.

This Supplement shall be considered a part of the User Agreement.

**TIW Service Provider Authorization: Elections By Product**

The Central Settlement service includes options to provide your service provider with messages, GUI access and reports. The provider will only be able to receive data for authorized accounts and will not be able to perform any updates or submissions to the system.
