WHAT IS ITP DATA ANALYTICS?

DTCC ITP Data Analytics is DTCC's performance measurement solution for Institutional Trade Processing (ITP) clients. It helps analyze and compare operational post-trade performance across ITP services by leveraging data from CTM® and TradeSuite ID®. The service delivers powerful analytical capabilities that enable post-trade market players to measure and compare operational performance with their counterparties and industry peers. A portion of ITP Data Analytics functionality, known as Operational Metrics, is included with a CTM and/or TradeSuite ID subscription. Additional capabilities are available via an add-on subscription known as Benchmarking.

WHAT ARE SOME OF THE KEY BENEFITS?

The modernized ITP Data Analytics user interface gives you access to key data on demand. The new user interface is customizable, allowing you to pick metrics most relevant to your needs, manage priority clients, and obtain dynamic visualizations and graphs on any metric. Tailored reports showcase different facets of your performance helping you identify areas of improvement, areas in which you are doing well, and how to reduce manual touches.

ITP Data Analytics allows users to:

- Quantify your post-trade processing behavior, providing analytical metrics regarding how you perform against any counterparty you select, how long it takes for you to match a trade, how many manual touches are involved in your process, the timeliness of affirmations, and more
- Monitor operational performance across all asset classes and compare it to industry averages, as well as individual counterparty timeliness and efficiency
- > Review feedback from counterparties against trade activity data
- Leverage a modernized user interface with an interactive dashboard for accessing the full suite of analytical products
- ➤ Access the new T+1 Scorecard which is available to users of CTM and certain TradeSuite ID subscriptions. This dashboard of specifically dedicated metrics relevant to T+1, can help measure and monitor your firm's level of preparedness for T+1 in the U.S. market

HOW DOES ITP DATA ANALYTICS HELP STREAMLINE POST-TRADE?

By providing you with post-trade data and industry insights, you can identify patterns to help make improvements and more informed decisions. The ITP Data Analytics service also provides a plethora of report types, including the T+1 Scorecard, that aggregates your data in different ways to help you prepare for industry events such as accelerated settlement in the U.S. and other regulatory changes, and better serve your priority clients.

HOW DOES IT WORK?

ITP Data Analytics consumes underlying transaction activity from CTM and TradeSuite ID daily. Your data is then aggregated and analyzed across multiple metrics and dimensions, providing you with insights about your operational performance.

Your dashboard is then compiled based on the product identifiers you designate.

The data is also aggregated and anonymized to provide you with Benchmarking functionality, comparing you to your peers, the industry, and priority clients.

All the data is displayed on a graphical and dynamic dashboard and can also be made available via a direct download.

WHAT REPORT TYPES ARE AVAILABLE?

Operational Metrics

- > **T+1 Scorecard:** Designed to provide you with operational performance metrics, industry benchmarks, and trend analysis to help prepare for the move to T+1 in the U.S. and eventually other financial markets
- > CTM Time Period Report: Provides you with metrics and analytics highlighting operational performance measurements with counterparties over a quarterly, monthly, or weekly time period
- > CTM Datafeed: Delivers the ability to access and download underlying transaction data for in-depth analysis, offered via a CSV download
- > TradeSuite ID Affirmation Report: Provides clients with analytics on the timeliness of confirms and affirmations based on TradeSuite ID data

Benchmarking

- > CTM Peer Comparison Report: Provides you with the ability to benchmark your own CTM matching performance against an anonymized group of your peers for specific CTM post-trade processing metrics, such as entry and matching
- > CTM Counterparty Analysis Report: Delivers a comparison of how individual counterparties are performing with you for specific CTM post-trade processing metrics such as entry and matching, and how that same counterparty is performing with the rest of the market in aggregate
