## Standard Usage for Brokerage Identification Number (BIN) Transaction 9/30/04

BIN Transaction is used to add, change or delete (de-network) a BIN. A BIN is a synonymous with brokerage account number, which can be listed at the Carrier on an annuity contract for networking purposes.

Listed are the fields applicable to the BIN transaction.

Note: Records and field that are required but not included in Standard Usage are Submitting Header (70) and Contra Header (72) records, as well as System Code, Record Type, Sequence Number and NSCC Control Number in 73-01.

Scenarios columns apply to field item #'s 7041 and 7045. Scenarios are the suggested way of handling these fields. DTCC will not edit these suggestions. From a DTCC standpoint, these fields will be edited as straight optional fields.

Standard Usage documents were reviewed and approved by the ACATS/IPS Pilot Working Group.
