The DTFEDS Function

A user may utilize the DTFEDS function in order to receive DTC Elective Dividend Information.

In general, the "Elective Dividend System Notices" (DTFEDS) function enables all DTC Participants to access information concerning elective dividend notices via FTP or NDM in a machine readable format.

Availability of DTF DTFEDS

The DTFEDS will generally be available from 1:00 A.M. until approximately 5:00 P.M. the next DTC business day.
