Subject:	AIP PARTICIPANT NUMBER FORMAT CHANGE

Effective **Friday, March 27, 2020** National Securities Clearing Corporation (NSCC) will implement enhancements to the **Alternative Investment Product Services** ("**AIP**") into Production. AIP is scheduled to migrate the new Alphanumeric Account Number Format coding on Thursday, March 26, 2020 <u>after</u> the 7:00pm (ET) End of Day Processing Cycle.

In May of 2018, DTCC announced an enterprise-wide, multi-year initiative to update business applications with a new, alphanumeric account number format to support the continued growth of new accounts and the expansion of new products and services.

DTCC's **Alternative Investment Product (AIP)** Services will be the first application to move to this new alphanumeric structure. The adoption of this new account format will ensure that AIP and other businesses can continue to expand and support a growing number of clients, bringing greater standardization to the industry.

To minimize impact on AIP clients, existing AIP Participant Numbers will <u>not</u> change and all AIP Participant Numbers will continue to be 8 bytes²; however, upon completion of this project, it's expected that all new AIP accounts will be issued in the new alphanumeric format allowing other businesses to continue issuing numeric accounts until they support the new, alphanumeric format.

PSE/Testing

Effective Friday, October 11, 2019 participants can begin testing the new alphanumeric participant number format in the <u>first</u> AIP cycle of the day at 9:00am (ET).

Participants are strongly encouraged to test these changes. Those participants who are interested in obtaining alphanumeric participant numbers as a Fund and/or Firm in the PSE Test Environment, must contact AIP Product Management at least ten (10) days <u>prior</u> to testing. This will ensure that proper setup is established in advance of testing these changes.
