As previously announced, the Fixed Income Clearing Corporation ("FICC") modernized its Real-Time Trade Matching ("RTTM<sup>®</sup>") web applications for the Government Securities Division ("GSD") and the Mortgage Backed Securities Division ("MBSD"). This modernization effort moved GSD RTTM, MBSD RTTM and RTTM Report Center to DTCC Portal creating one central location for Members to access their DTCC products. The initiative also created a single sign on for GSD Members by combining DVP and GCF into a single GSD RTTM.

FICC is now ready to make these applications available to Members in the production environment on **Monday, June 28, 2021**. In preparation, the required production access for Super Access Coordinators will be made available on **June 21, 2021**. This will give Members the opportunity to provision their users with the appropriate access to the FICC RTTM products.

Additionally, the legacy RTTM Web application will run in parallel with DTCC Portal until **Friday, August 20, 2021** giving members ample time to complete the process of provisioning their users and become familiar with navigating the new application. After **August 20, 2021**, the legacy RTTM Web application will not be accessible by Members.

## **Next Steps:**

Super Access Coordinators will receive an email correspondence announcing changes were made to your CRS profile in production. This email is the same correspondence that was received when the Access Coordinator profiles were loaded to PSE. If you need any assistance with this please contact our Global Entitlements team (<u>entitlements@dtcc.com</u>)

Also, Member's Super Access Coordinators have already been provisioned access to the new FICC RTTM products in the PSE environment. Now, the Super Access Coordinator will need to provision those users with Production access.

Members should have completed the connectivity test to the new URLs for accessing the new RTTM Web application. Those members who have not completed this effort will need to work with FICC Integration to do so. The FICC Integration team can be contacted via email (FICCintegration@dtcc.com).
