OBJECTIVES OF THIS CHAPTER 4

AIMCPI OVERVIEW

As part of DTC's custody service, the DTC AIM/Custody system generates the Custody Certificate and Document Detail Position file. This file contains close-of-business information for each requesting Participant. There are two record layouts for this file; a certificate file and a document file. The document file contains two different record types. One is for active physical documents and one is for missing documents. Participants may want to retrieve this file after the completion of the AIM/Custody end-of-day process and reconcile their internal Custody systems to DTC's Custody position.

This document contains the record layouts of the Custody Certificate and Document Detail Position file.

Transmission Mode

The Custody Certificate and Document Detail Position file is offered via the FTP or NDM data transmission facility, under the function name AIMCPI.

The 26-byte transaction header, shown below, is prefixed to every Certificate Detail Position Information Record.
