Day Deliver Orders(Dos) will not be accepted on Wednesday, November 11, 2020. Normal processing will resume on Thursday, November 12, 2020.

In addition, the PTS functions "DRS" and "DRSP" will not be available and the CCF transmission files DRX1 and DRX5 will not be accepted.
