<b>Subject:</b>	Real Time Trade Matching Web Application Modernization Initiative

As previously announced in Important Notice [GOV934-20](#) and the two industry calls held on August 27, 2020 and September 1, 2020, the Fixed Income Clearing Corporation (“FICC”) is working on a modernization initiative on the Real-Time Trade Matching (“RTTM”) web application for the Government Securities Division (“GSD”) and the Mortgage Backed Securities Division (“MBSD”). FICC is ready to move this initiative forward and now need Members to test their network connectivity to the new GSD RTTM and MBSD RTTM web applications in FICC’s Test and Production environments.

This next step requires Members to test access to the new Uniform Resource Locator (“URL”) for the RTTM web application. FICC is providing Members with two options to test their connectivity to the new URLs:

1. Members can choose to test independently or “unassisted” using the new URLs, by accessing the guide document [“FICC Members Network Connectivity Options \(New URLs\)”](#) located in the DTCC Learning Center. 2. Members can choose to test with guidance from the FICC Integration team by sending an email to [FICCIntegration@dtcc.com](mailto:FICCIntegration@dtcc.com) requesting to schedule a date and time to test.

In order to complete this portion of the initiative, all Members are required to provide an email confirmation, including Member account number, to FICC Integration by **January 29, 2021**, stating successful access to the new URL(s) (MBSD and GSD).
