Subject to regulatory approval, NSCC plans to decommission its DTCC Limit Monitoring risk management tool. DTCC Limit Monitoring enables Members to monitor trading activity on an intraday basis of their organizations and/or their correspondent firms through the review of post-trade data. Once this service is decommissioned, Members will no longer receive email alerts or output files from Limit Monitoring. A subsequent Important Notice will be distributed to announce the specific decommission date, currently expected to be in November 2024.
