**PLEASE NOTE THAT A REPRESENTATIVE AUTHORIZED TO TRANSACT BUSINESS WITH DTC MUST BE PRESENT AT THE LOCATION OF EACH PARTICIPANT ON EACH BUSINESS DAY, INCLUDING THE DAY PRIOR TO THE SCHEDULED HOLIDAYS, BETWEEN THE HOURS OF 9:00 A.M. AND 5:30 P.M., NEW YORK CITY TIME AND UNTIL THE PARTICIPANT'S ACCOUNT WITH DTC IS SETTLED AND IN BALANCE.**

- A. Deposits: CNS Deposits received in the night drop on Friday, May 23, 2008 will be available for credit toward CNS settlement obligations of Tuesday, May 27, 2008. **DTC will not provide record date protection on deposits made in the night drop of Friday, May 25, 2008.**
- B. Depository Trust PTS night deliveries (NDOs) and night MQ and CCF Deliver Order Transmissions should be submitted on Friday, May 23, 2008 for processing and settlement on Tuesday, May 27, 2008.
- C. Night intra-account movement type transactions, (i.e., transfers from the MA account and transfers from the NA account) should be submitted on Friday, May 23, 2008 for processing and settlement on Tuesday, May 27, 2008.
- D. Requests for night Bearer COD withdrawals submitted on Friday, May 23, 2008 will be available for pickup on Tuesday, May 27, 2008.
- E. Requests for Withdrawal-by-Transfers (WTs): **To avoid dividend problems, you are reminded to exclude any securities that are of record on Monday, May 26, 2008 from your submissions of Withdrawal by Transfers (WTs) made by PTS on Thursday, May 22, 2008 or by CCF prior to the 8:30 A.M. cut-off on Friday, May 23, 2008.**
- F. Participant Browser Services (PBS) and the Participant Terminal System (PTS) will be available on Monday, May 26, 2008 for limited processing.
- G. Canadian Dollar Link (CDL)  
**DTC will be open on Monday, May 26, 2008 to process and settle transactions submitted via the Canadian Dollar Settlement Link.**
