Subject: **NSCC MODIFIES CYCLES TIMES TO ITS DISTRIBUTION OF
NSCC 400 BYTE INTRA-DAY MULTI-CYCLE CONTRACT OUTPUT**

Beginning processing date **Friday, July 16, 2010**, NSCC will modify its intra-day machine readable contract file distribution. This modification will synchronize all LSN, NASDAQ/QSR/OTC, RIO and CORR multi-cycle outputs to prepare for the implementation of the Universal Trade Capture (UTC) application. The UTC will provide participants with the option of receiving all contract information in one file or in real-time. Output needs to be aligned prior to implementation to facilitate participant parallel testing.

Participants should include the cycle number (or unique data set) on all trade submissions. NSCC also recommends participants use the "Application Multi-Cycle Counter" in position 55-56 on the AutoRoute header to determine whether all cycles of a particular product ID was received. This field provides an incremental cycle number for each output file with a final cycle number of 98.
