	(ELIS)

DTC's Data Delivery Service files and Eligible Securities files (ELIS) are being enhanced to include additional data elements. There is no disruption to existing processing as the new data elements are being added to available filler on each record. The record lengths will not change and no action is required unless a Participant wishes to process the new data elements.

These changes will be implemented on June 10, 2011.

New data elements

Issue Type describes the category of the Security. Possible values are 1 – Equity or 5 – Corporate.

Issue Type is being added to the:

- Eligible Corporate Securities file (ELISC)
- Eligible Corporate Securities Changes file (ELISCA)

The **Global Lock Indicator** is used to determine if a Security is currently frozen and globally locked for any activity at DTC. Valid values are 'Y' – Yes and 'N' – No. .

The Global Lock Reason Code provides a reason when the Global Lock Indicator is set the 'Y'. Valid values are space and '0' to '9'.

- This field is set to space when the Global Lock Indicator = 'N'. It means the Global Lock Reason Code is not applicable.
- A Global Lock Reason Code = '0' means the Security is globally locked.
- A Global Lock Reason Code = '1' means the Security has been globally locked by DTC operations for regulatory control reasons. Values '2' through '9' are reserved for future use.

The Global Lock Indicator and the Global Lock Reason Code are being added to the:
