On July 27, 2012; Citibank, N.A. (the Depositary Bank) informed holders through DTC's Important Notice B#1136-12 that effective close of business July 31, 2012, the Depositary Bank would suspend DR facilities affected by the French Transaction Tax (FTT) for all deposits and withdrawals until further notice.

Although guidance is still needed to understand the impact of the FTT on issuance and cancellations of ADRs, at this time, the Depositary Bank will not close its books as previously announced and it will continue to issue and cancel DRs. Investors should consult with their tax advisors as transactions for issuances, transfers and cancellations effected as of August 1, 2012 may still be liable for the FTT.

The Depositary Bank will continue to monitor the developments of the FTT and to work with legal counsel to determine the impact of the FTT on ADR issuances and cancellations
