Trade input for the Real Time Transaction System (RTTM) for Corporate, Municipals, and UITS (CMU) for trade date Thursday, April 5, 2012 will be accepted no later than 8:00pm on Thursday, April 5, 2012.

<u>REAL TIME TRANSACTION SYSTEM (RTTM) FOR CORPORATES,</u> <u>MUNICIPALS & UITS (CMU)</u>

Although interdealer trading activity in Municipal Bonds, Corporate Bonds and UITs may occur on Friday, April 6, 2012, participants are requested to submit such transactions to NSCC CMU Real Time Trade Matching (RTTM) on Monday, April 9, 2012 using a trade date of April 9, 2012 for processing purposes. Firms should reference DTCC's December 20, 2007 New Project Update for information on how to code such Municipal trades with the MSRB-required M040 indicator.:

They cannot be submitted until April 9, 2012 since NSCC CMU RTTM is closed on April 6, 2012. Firms must enter the actual Trade Date and trade time and submit by 7:45 a.m. on April 9, 2012.

Muni <u>Inter-dealer</u> trades executed on April 6, 2012 must be submitted on April 9, 2012 with a Trade Date of April 9, 2012, since April 6, 2012 is an invalid Trade Date for Inter-dealer trades in RTTM. <u>Under MSRB rules</u>, the time of trade on inter-dealer trades must be 00:01:00 and trade submission into RTTM must occur by 7:45 a.m. on April 9, 2012. **Dealers are also required to include the M040 special condition indicator that allows MSRB's RTRS System to identify these inter-dealer trade reports were made under special circumstances using a special trade date and time.**

CONSOLIDATED TRADE SUMMARY AND SUPPLEMENTAL

The Consolidated Trade Summary will be available on Thursday Evening, April 5, 2012. The Supplemental Consolidated Trade Summary, Cycle #1 will be available on Friday Night/Saturday Morning, April 6/7, 2012. Cycle #2 will be available on Monday, April 9, 2012.
