SUBJECT:	UPDATE - NEW REGULATORY DATA ELEMENT REQUIRED ON MUNICIPAL BOND TRADES SUBMITTED TO NSCC'S REAL TIME TRADE MATCHING SYSTEM (RTTM) FOR MUNICIPAL SECURITIES RULEMAKING BOARD'S (MSRB) REAL-TIME REPORTING SYSTEM (RTRS)

As reported in NSCC Important Notice A#7362, P&S#6932, dated January 23, 2012, in order to enhance regulatory price data for the reporting of Municipal bond trades, in November, 2012 the Municipal Securities Rulemaking Board (MSRB) will require its participants to submit a Dollar Price ("Regulatory Dollar Price" or RDP) on all Interdealer trades reported to MSRB. Dealer to Customer trades are not impacted by the changes. This change was also announced in the MSRB Notice 2012-30, dated June 4, 2012, available at: <http://www.msrb.org/Rules-and-Interpretations/Regulatory-Notices/2012/2012-30.aspx>.

NSCC's CMU Real Time Trade Matching (RTTM) system will accept RDP on MT 515 trade input instructions and will forward participant designated transactions with the RDP data to MSRB. In connection with this change, a new Subqualifier for RDP will be added to the MT 515, as detailed below:

Appendix I to this Important Notice provides additional details in red font regarding the new RDP field.

Note that the existing Dollar Price field on the MT 515 **cannot** be used to submit RDP. The functionality of the existing Dollar Price field will not change and will continue only to be used for Participants electing to submit and match When Issue or Syndicate Takedown trades with dollar price (*Tag :90A: Block/Qualifier :DEAL/ Subqualifier/Options /PRCT/ Description Deal Price*). Firms

submitting the existing Dollar Price field to match a “When Issue” or “Syndicate Takedown” trade must also separately report the dollar price in the new RDP field.

RDP will be added to all CMU RTTM MT 518 output messages to Participants as well. In connection with this change, a new Subqualifier for RDP will be added to the MT 518, as detailed below:

MSRB Real-Time Trade Reporting System (RTRS)

In connection with these specifications, and in addition to the new Subqualifier for RDP referenced above, MSRB is adding two new error codes:

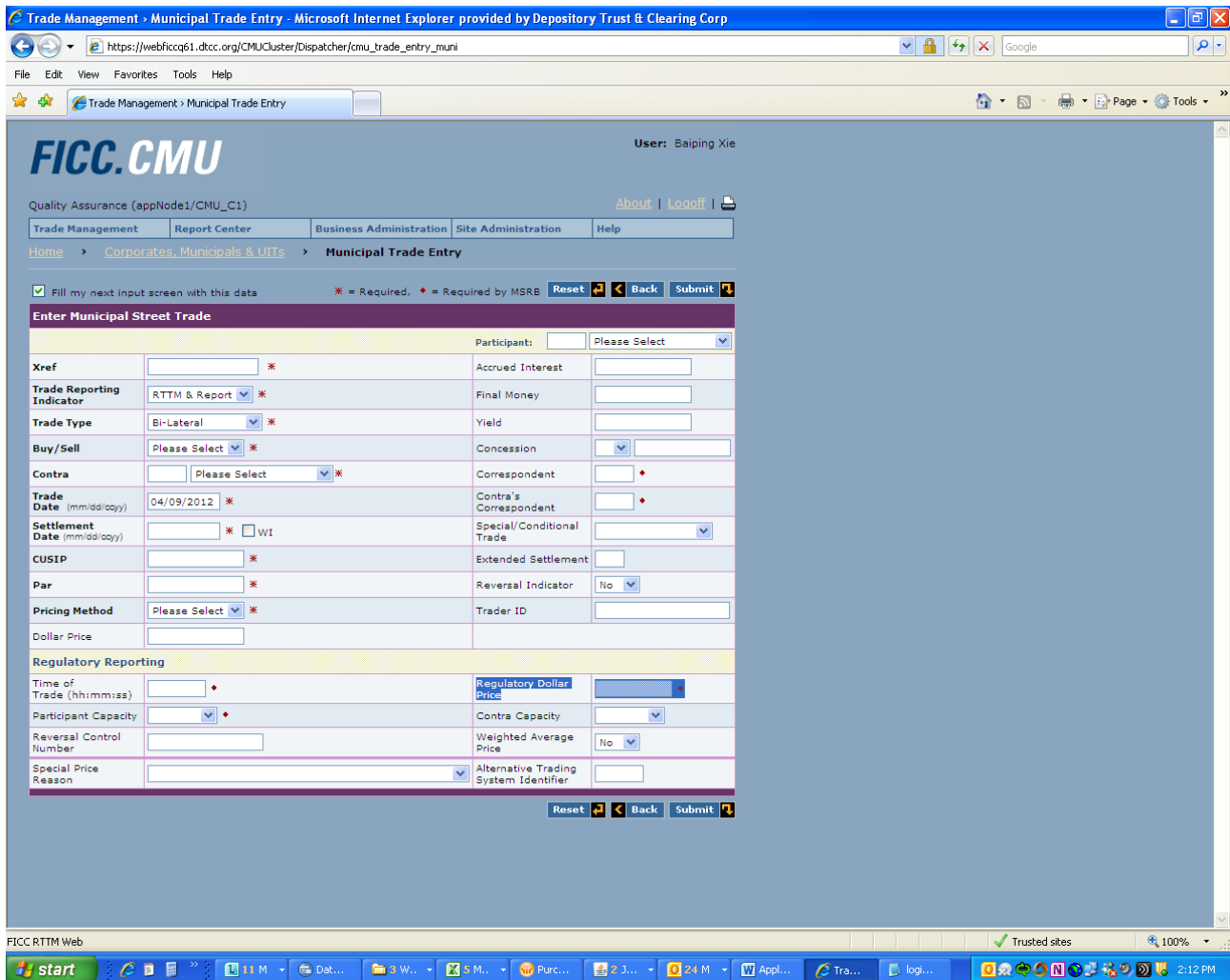
- Q33F - QUEST Seller and buyer Regulatory Dollar Price differ
- U53B - UNSAT Regulatory Dollar Price missing

Key Features of RDP in RTTM

- RDP will be a Regulatory field and will **not** be used for matching. In this respect, it will be treated similarly to the “Time of Trade” field, which is also a Regulatory field and is not used to match a trade.
- Like other Regulatory fields, RDP can be modified in RTTM either pre- or post-match, while the trade is still active in RTTM (generally through settlement date).
- RDP will not appear on the end-of-day Fixed Income Municipal Bond Contract Machine Readable Output file (AutoRoute #02032237) or on the CMU RTTM Print Image Reports (Contracts) in RTTM Web Report Center. It will appear on MT 518 messages and on RTTM Web.

RTTM Web

The RDP input field will be added to the Regulatory trade input section on RTTM Web, and will also be available for viewing on RTTM Web (see screen shot below).



Testing and Implementation Schedule

Service Bureaus and Participants with an in house system that transmit MT 515 trade messages to CMU RTTM via MQ must test their Municipal Bond Interdealer trades with NSCC and MSRB prior to implementation. The test system is expected to be available with the new RDP functionality beginning on **June 20, 2012**. Participants should email qa@ficc.com to arrange for testing.

Implementation of the RDP trade input requirement is expected in November 2012. The exact production date will be communicated via future Important Notice.
