

## **File Transmission Layouts for Dealer Commission Report NDM Format**

### **Purpose**

The Dealer Commission Report reflects all commissions and related trade data that MBSCC will, on behalf of the Brokers, collect from the Dealers.

### **Frequency**

Monthly - Month-end.

\*All records are of equal length - 122 bytes.

\*There are 3 different logical record types, each uniquely identified by a card code 01 through 02, & 99.

### **ACCOUNT / REPORT HEADER RECORD (CARD CODE 01)**

Control record which signifies the beginning of the report for a given account. Contains recipient account and report identification items.

### **DEALER COMMISSION DETAIL RECORD (CARD CODE 02)**

Detail record containing commission information on a single trade formatted for the dealer accounts only.

### **TRAILER CONTROL RECORD (CARD CODE 99)**

Trailer record indicates the end of the report for the recipient account.
