Standard Usage for Status Reason Codes on Confirmations

Status Reason Codes are used to explain why a transaction was rejected. In ACATS, there are two types of rejects, hard rejects (HRJ) and soft rejects (SRJ). A hard reject is used when a Carrier does not expect corrective action to be taken on the ACAT transaction. When a HRJ is sent, it terminates that specific ACATS transaction. A soft reject is used when a Carrier cannot process the transaction as is but is willing to receive additional information in order to make the transaction in good order.

Soft Rejects (SRJ) should only be used for CAT transactions. Use HRJ for all other transaction types (ACATS or Non-ACATS initiated).

Standard Usage documents were reviewed and approved by the ACATS/IPS Pilot Working Group.
