Amendment No. 1 to SR-FICC-2017-007

Fixed Income Clearing Corporation ("FICC") is filing this partial amendment ("Amendment") to SR-FICC-2017-007 ("Rule Filing"), which was filed with the Securities and Exchange Commission ("Commission") on April 6, 2017. The Rule Filing is proposing to adopt (1) the Clearing Agency Policy on Capital Requirements ("Capital Policy") of NSCC and its affiliates, The Depository Trust Company ("DTC") and National Securities Clearing Corporation ("NSCC," together with DTC and FICC, the "Clearing Agencies"); and (2) the Clearing Agency Capital Replenishment Plan ("Capital Replenishment Plan") of the Clearing Agencies.

By this Amendment, the Clearing Agencies are proposing a technical revision to the Rule Filing to correct the table of contents in each of the Capital Policy and the Capital Replenishment Plan, and to correct the page numbers on the Capital Replenishment Plan. The pages showing these changes are redacted. The Clearing Agencies shall file these pages separately with the Commission.
