Amendment No. 1 to SR-NSCC-2017-005

National Securities Clearing Corporation (“NSCC”) is filing this partial amendment (“Amendment”) to SR-NSCC-2017-005 (“Rule Filing”), which was filed with the Securities and Exchange Commission (“Commission”) on April 6, 2017. The Rule Filing is proposing to adopt the Clearing Agency Liquidity Risk Management Framework (“Framework”) of NSCC and its affiliates, The Depository Trust Company (“DTC”) and Fixed Income Clearing Corporation (“FICC,” and together with DTC and NSCC, the “Clearing Agencies”).

By this Amendment, the Clearing Agencies are proposing a technical revision to the Rule Filing to correct the table of contents in the Framework. The page showing these changes is redacted. The Clearing Agencies shall file this page separately with the Commission. Confidential treatment of the corrected page is being requested pursuant to 17 CFR 240.24b-2.
