Amendment No. 1 to SR-NSCC-2017-005

National Securities Clearing Corporation ("NSCC") is filing this partial amendment ("Amendment") to SR-NSCC-2017-005 ("Rule Filing"), which was filed with the Securities and Exchange Commission ("Commission") on April 6, 2017.
