Listed on this notice are MMI settlement holidays through the year 2015. They are identified by the letters MMI in parenthesis after the holiday's name in the first column. London holidays are also listed, and similarly identified. Except as indicated by footnote 3, DTC may be open for other services on MMI settlement holidays.

Under DTC's Money Market Instrument (MMI) programs, including Commercial Paper program, DTC receives daily instructions from MMI issuers' issuing/paying agents for new MMI issuances. DTC does not accept into its programs MMIs with maturities of five years or less that are targeted to mature on a day on which DTC is closed for MMI settlement services. Moreover, where such MMIs pay income or principal indexed to LIBOR, DTC does not accept those MMIs targeted to mature on a London holiday. Additionally, when determining MMI income and principal payment dates as they arise, and maturity payment dates for MMIs with maturities of more than five years as they arise, DTC again takes into consideration MMI settlement holidays, and for those paying income or principal indexed to LIBOR, London holidays as well. DTC's systems contain at all times a six-year calendar of both anticipated MMI settlement holidays and anticipated London holidays that issuing/paying agent (IPA) and other participants should be aware of and avoid.

IPAs and dealers are advised to inform their issuer clients whose MMI programs are (or become) eligible for DTC's programs to schedule new issuances and maturities away from these MMI settlement holidays.

^{10.} Holiday falls on a Sunday. Note that DTC is scheduled to be closed for MMI and other U.S. services on Monday July 5, 2010.

¹¹ Spring Bank Holiday was moved from May 28, 2012 to the following Monday, June 4, 2012 in celebration of the Queen's Diamond Jubilee.
