Subject:	Underlying Firm Symbol (UFS) List Changes

In 2004, NSCC and the ICI Bank, Trust and Retirement Advisory Committee (BTRAC) decided to create an Underlying Firm Symbol (UFS). The UFS is a unique identifier assigned to Banks, Trusts, TPAs, consultants and others who are not NSCC members but who do clear through an NSCC participant. The objective of the UFS is to identify underlying entities, excluding broker dealers, within fund accounts, creating greater transparency. The UFS is now available on Fund/SERV and Networking records and can be utilized to communicate to funds the underlying firm that is transacting with their fund company.

DTCC maintains the list of UFS as a central resource for its NSCC members. NSCC members are responsible for the accuracy of the information they provide when requesting a UFS member be added to the existing list. Members of BTRAC and NSCC recently met to review and scrub the growing list of Underlying Firm Symbols that have been requested and assigned over the years. As a result of this exercise, an updated UFS list has been created and will become effective on **March 4, 2013.**

Listed below are the Underlying Firm Symbols that will be eliminated and their associated replacement symbols. Participants storing the UFS on their platforms are encouraged to review their internal system and substitute the replacement symbol for the eliminated symbol (where applicable) prior to the effective date.
