Subject:	PARTICIPANT TESTING OF THE CNS ACATS AND DTC SETTLING ASSETS PROJECT

In May 2014, subject to Securities and Exchange Commission (SEC) approval, the National Securities Clearing Corporation (NSCC) and the Depository Trust Company (DTC) plan to implement the Continuous Net Settlement (CNS) Automated Customer Account Transfer Service (ACATS) and DTC Settling Assets Project as outlined in NSCC Important Notice A7556 P&S 7126 and DTC Important Notice B1988-12, both dated December 21, 2012.

This Notice publishes details about participant testing setup, script, and cases. The project is scheduled to begin participant testing in the Participant Services Environment (PSE) on January 24, 2014, and scheduled to be migrated to the Production environment on May 30, 2014.

Testing Setup

Testing for this project involves output from four systems: ACATS, CNS, DTC, and the Obligation Warehouse (OW).

ACATS

For OW, participants should take in and process MQ messages.

Additionally, the Intraday/End-of-Day (EOD) OW Position file will be available, AutoRoute number 02980703 in PSE or 02050703 in Production.

To test DTC settlement web screens in PSE, participants should follow these steps:

1. Confirm the accounts you would like to access in the test environment by contacting the Connectivity Activation and Participant Support (CAPS) group at 888-382-2721, option 5, then option 3. Please have your participant account details available when you call. If necessary, participants may be required to complete a router form and establish connectivity (please note that this step can take up to 10 business days).
2. Verify that you have an access coordinator for the Settlement Web product in PSE by contacting the Customer Support Center at csc@dtcc.com.
3. The Settlement Web PSE access coordinator at your firm should provision the user IDs in PSE with the proper roles.

Test Script

DTCC will provide a script that guides participants through testing in a weekly cycle. Each participant should arrange to have a test partner: in the script, one partner acts as the deliverer of the ACATS transfer; the other, the receiver. The script will provide details for what the Deliverer and Receiver should do, and what results each party should expect. The script will

include the transfer of both long and short positions. The script will repeat every week throughout the testing period.

These scripts will be posted to the Clearance Services Learning Center website. Instructions on how to access this site are listed below.

Testing ACATS reversals

There will be specific days when DTCC will facilitate the testing of the reversal of ACATS obligations which would occur in the event that a participant defaults. The exact dates of this reversal testing are to be determined: DTCC will publish a future Notice with the exact dates.

Test CUSIPS

DTCC will create test CUSIPs specific to this project. A list of these CUSIPs will be provided on the Clearance Services Learning Center website.
