SUBJECT: NEW OUTPUT FILE CONTAINING CORPORATE BOND AND UIT EXECUTING BROKER IDENTIFIERS AND IMPLEMENTATION DATE FOR EXECUTING BROKER IDENTIFIERS (MPID_s) TO BECOME MATCHING CRITERIA FOR CMU RTTM CORPORATE BOND AND UIT TRADES

Background

In order to assist Members to match corporate bond and UIT trades in the Corporate Bond, Municipal Bond, UIT Real Time Trade Matching system (CMU RTTM), NSCC will make available a new data file containing corporate bond and UIT executing broker identifiers (aka Market Participant IDs) in Machine Readable Output beginning January 20, 2017.

A file for municipal bond executing broker identifiers exists today (AutoRoute #02030771). The AutoRoute number for the corporate bond/UIT file will be #02032440 in production with a product description of “Corporate Bond and UIT Executed by Broker Masterfile”. The AutoRoute number in the test Participant Services Environment (PSE) will be 02982440. See the file’s layout below.

Executing broker identifiers are required trade submission data on all CMU RTTM trades. **These identifiers will become matching fields for corporate bond and UIT trades on Trade Date April 7, 2017** (see June 16, 2016 Important Notice A#8212¹).

The executing broker identifiers are already matching fields for municipal bond trades. Members requested the new Corporate Bond and UIT Executed by Broker Masterfile to support matching corporate bond and UIT trades in CMU RTTM.

Adding Your Firm’s and Your Correspondents’ Executing Broker Identifiers

Members need to provide executing broker identifiers used on their corporate bond and UIT trades in order for them to appear on the new file. Members already provide this information to NSCC for themselves and all their correspondents effecting municipal bond trades.

Between January 9, 2017 and January 13, 2017, Members should complete an Excel spreadsheet that will be provided by NSCC in early January and return it to NSCC Account Administration at NSCCAA@dtcc.com. This data will be included on the Corporate Bond and UIT Executed by Broker Master File produced starting January 20, 2017. The Corporate Bond and UIT Executed by Broker Master File will be updated and made available to Members on a daily basis.

As we get closer to the January 20, 2017 implementation, NSCC Members will be instructed on how to obtain the new file.
