SUBJECT: REQUIREMENT TO PROVIDE EXECUTING BROKER IDENTIFIERS (MPIDs) FOR NEW NSCC CORPORATE BOND AND UIT EXECUTED BY BROKER MASTERFILE OUTPUT FILE

Background

As detailed in Important Notice A#8283, P&S#7858, dated November 2, 2016, NSCC will make available a new data file containing corporate bond and UIT executing broker identifiers (aka Market Participant IDs) in Machine Readable Output beginning January 20, 2017. This change will assist Members to match corporate bond and UIT trades in the Corporate Bond, Municipal Bond, UIT Real Time Trade Matching system (CMU RTTM).

Executing broker identifiers are required trade submission data on all CMU RTTM trades. These identifiers will become matching fields for corporate bond and UIT trades on Processing Date April 7, 2017.

Adding Your Firm's and Your Correspondents' Executing Broker Identifiers – Initial Load

Members must provide executing broker identifiers used on their CMU RTTM corporate bond and UIT trade submissions in order for them to appear on the new file. Members generally already provide this information to NSCC for themselves and their correspondents effecting municipal bond trades.

Between December 14 - 15, 2016, Members will be contacted by DTCC via email with an Excel spreadsheet to be completed with their own and their Correspondents' executing broker identifiers. The spreadsheet should be returned to NSCC Account Administration at NSCCAA@dtcc.com and copy efanning@dtcc.com. Once the email is received, please return the spreadsheet ASAP, but no later than January 13, 2017. The executing broker identifier data will be included on the Corporate Bond and UIT Executed by Broker Masterfile produced beginning the night of January 20, 2017. The file will be updated and made available to Members on a daily basis.

Any subsequent executing broker data changes to the initial load can be submitted via revised spreadsheets from January 17 to 19, 2017.

Adding Your Firm's and Your Correspondents' Executing Broker Identifiers - Ongoing

Following the initial load of corporate bond and/or UIT Market Participant IDs, any deletions and/or additions requested for corporate bond and/or UIT executing broker symbols, with the expected effective date of January 23 or later, must be submitted to NSCC using the DocuSign template available at the link below. Other methods to update Market participant IDs will not be accepted. NSCC Members should submit these requests at least 3 business days prior to the effective date of such IDs. Any updates not meeting information or timing requirements may be rejected. Any questions regarding these requests can be directed to NSCCAA@dtcc.com.
