<b>Subject:</b>	<b>CBRS Phase 6 Production Postponed to July 15, 2016</b>

The Cost Basis Reporting Service (CBRS) is preparing deployment of CBRS Phase 6 to support the changes on the Tax Lot Input Record to further support the transfer of cost basis.

The adjustments to the CBRS Tax Lot Input and Output layouts were specified in the DTCC Solutions, LLC Important Notices: CBRS006.2015, dated December 17, 2015; and testing announced in CBRS002.2016, dated April 19, 2016.

The production release date has been changed. The CBRS updates are now scheduled to be in production on **July 15, 2016**. DTCC received a number of requests to change the date due to system freezes ahead of the Brexit vote. Beginning on July 15, 2016, all submissions to CBRS must use the new layout and all output will be published in the new format.

### **Testing**

The Participant Services Environment (PSE) CBRS system was migrated to the new formats and will continue to accept and edit files according to the definitions on the new record layout. DTCC Web Direct input will also continue to be available.

If a firm submits cost basis records and CBRS accepts the data, then output will be generated during the end of day process. Below is a list of the relevant files.
