In Important Notice <u>CBRS002.17</u> dated, August 1, 2017, DTCC announced the planned enhancements to the Cost Basis Reporting Service (CBRS). DTCC will also make changes to the CBRS User Master File to accommodate the Phase 7 Enhancements. Please note these are optional changes. These changes will be implemented into production **November 10, 2017**. Below is a list of all the input and output files. Please see below for additional information regarding testing and Master File changes.

## **Testing**

The Participant Services Environment (PSE) CBRS system will accept and edit files according to the definitions on the new record layout beginning October 6, 2017 October 12, 2017. DTCC Web Direct input will also be available.

If a firm submits cost basis records and CBRS accepts the data, then output will be generated during the end of day process.

## **Changes to the Cost Basis User Master File**

DTCC will also make changes to the CBRS Master File MRO 02981666 in PSE and 0256166 Production. The changes will also be included to the CBRS User Masterfile WebDirect Download in PSE 02981667 and 02561667 Production.

There will be a new Search Firm Type value of NSCAIP, which will create a new type of inactive record to allow CBRS Firm Types (DTCPRT, NSCPRT, and CBRACT) to add its NSCC AIP Firm number to the CBRS User Master File.

Adding a NSCAIP firm number to an existing CBRS Firm Type will allow a CBRS user to map its NSCC AIP number to its existing CBRS account. This cross-reference will be necessary in the cases where a firm has a DTCPRT and a different NSCC AIP number.
