Via this notice DTCC is informing Transfer Agents of a new and improved method of submitting a Notice of Transfer Agent Change Form #17Ad-16 to DTC. The current procedure is to download the form, enter the information, save it and email the document to DTCC in a pdf format.

To simplify the process, DTCC partnered with DocuSign to allow transfer agents to complete and submit the form on-line. To submit a 17Ad-16 TA change form and submit to DTC, click on the attached link:

When the page opens, click on **Notice of Assumption or Termination of Transfer Agent Services Form 17Ad-16**, under **ESSENTIALS** on the right side of the page.

The information is submitted on line and allows Transfer Agents to upload a spreadsheet when there is a large amount of issues involved. Once the information is received, the submitting Transfer Agent will receive a confirmation of completion.




