DTC is targeting July 24, 2017 to begin parallel production testing of ISO 20022 Reorganization Lifecycle messages. The onboarding and subscription set-up process required for testing generally takes a few weeks to complete. Clients wishing to take full advantage of the test period by starting on July 24th should complete and return to DTC the attached Onboarding Questionnaire no later than June 22, 2017. Note that DTC will accept questionnaires after June 22nd, however, bear in mind that the set-up timeline could delay the start of your testing. Be sure to contact the transformation team if you have any questions or need assistance completing the questionnaire. Completed questionnaires should be sent to <u>catransformation@dtcc.com</u>.

Testing of the ISO messages is critical as they will replace CCF lifecycle processing files such as CSHSET, which are slated for retirement on December 31, 2018. Please see Important Notice <u>B#5647-17</u> for the complete list of CCF files that will be retired on December 31, 2018.

Live production data will be used for testing. It is intended to be sent to your UAT environment until you are ready to "go live" in your production environment.
