Effective, **July 9, 2018**, National Securities Clearing Corporation (NSCC) will implement new retirement social codes. Social codes are available in **Fund/SERV®**, **Networking**, **DTCC Payment aXis®**, **ACATS and Mutual Fund Profile Service II** (see Important Notice <u>A8532</u> for information on MFPSII Profile Security changes). The new social codes are intended to provide further transparency to both firms and funds to more accurately identify account types, which assists in account oversight.

Please note, the addition of these new social codes necessitates leveraging **alpha/numeric** values. NSCC record layouts currently support alpha/numeric values for the Social Code field; clients should review their systems to ensure they are able to support alpha/numeric social code values. Clients are strongly encouraged to review and update the mapping of accounts on their systems to the appropriate NSCC social code when communicating with your contra party through NSCC.
