## **September 24, 2018 Deployment Date**

As previously announced in Important Notice [A8587](#), NSCC is redesigning and improving its CMU RTTM Web system. **New CMU RTTM Web will go into Production on Monday September the 24<sup>th</sup>.** Firms will continue to access the application as they do today with new trade input and output screens in production on that date.

## **Mandatory Participant Testing**

Firms are required to complete mandatory testing prior to the deployment. If you have not completed testing yet, contact the DTCC User Acceptance Test (UAT) group @ [FICCIImplementation@dtcc.com](mailto:FICCIImplementation@dtcc.com) to coordinate this effort as soon as possible. The UAT team will provide you with additional instructions, a set of test scripts, and a copy of our '*Quick User Guide*' for your convenience.

## **Training**
