Participants can use DTC TaxRelief™ service over Corporate Actions Web (“CA Web”) to electronically certify all or a portion of their position entitled to the applicable withholding tax rate. Participants are urged to consult TaxInfo<sup>SM</sup> respectively before electronically certifying their instructions over CA Web.

## **Non-Arm's Length**

Only the following beneficial owners are eligible for the exempt 0% rate on the **non-arm's length Interest**:

1. U.S. Residents as defined in Canadian TaxInfo
2. Eligible Canadian Residents as defined in Canadian TaxInfo

All other holders should elect at the unfavorable rate of 25%.

**Unfavorable Rate:** You may elect to receive the non-arm's length interest at a rate of \$0.0255 per unit this amount represents **less the 25%** Canadian non-resident withholding tax). **DEFAULT Exempt 0% tax:** You may elect to receive the non-arm's length interest at a rate of \$0.034 per unit **less 0% tax (tax exempt)**.
