Subject:	Submission of Rule Filing SR-FICC-2019-003 – Revise MBSD VaR Floor

On July 18, 2019, Fixed Income Clearing Corporation ("FICC") filed a proposed rule change (SR-FICC-2019-003) ("Rule Filing") with the Securities and Exchange Commission ("SEC") pursuant to Section 19(b)(2) of the Securities Exchange Act of 1934, as amended. The purpose of the Rule Filing is to change the calculation of the VaR Floor and the corresponding description in the FICC Mortgage-Backed Securities Division ("MBSD") Clearing Rules to: (i) allow FICC to adjust the "VaR Floor percentage" (as defined in the Rule Filing) within a proposed range specified in the proposed rule change when FICC's review of the VaR Floor percentage indicates that the VaR Floor percentage is not sufficient to cover FICC's credit exposure to each Clearing Member fully with a high degree of confidence, (ii) state that Clearing Members would be notified in advance of any such adjustment to the VaR Floor percentage, (iii) designate that the VaR Floor percentage would be subject to at least monthly model performance monitoring, and (iv) make certain technical changes.
