#### **Purpose**

The Uncompared Report reflects uncompared Pool Instructs ("PID's") and, if applicable, DK status.

#### **Frequency**

Daily.

#### **Record Layouts**

- \*All records are of equal length 228 bytes.
- \*There are 3 different record types, each uniquely identified by card code, as follows: card codes 01 through 02, & 99.

#### ACCOUNT / REPORT HEADER RECORDS (CARD CODE 01)

Control record which signifies the beginning of the report for a given account. Contains recipient account and report identification items.

#### **UNCOMPARED POOL SUBMISSION DETAIL RECORD (CARD CODE 02)**

Detail record containing a single uncompared pool submission.

#### TRAILER CONTROL RECORD (CARD CODE 99)

Trailer record indicates the end of the report for the recipient account.

X - alphanumeric

A - letter

Y - year

M - month

D - day

NOTE: If a number is padded, it will be padded with zeroes on the left in the integer part and on the right in the decimal part (if one exists). If text is padded, it will be padded with spaces on the right.
