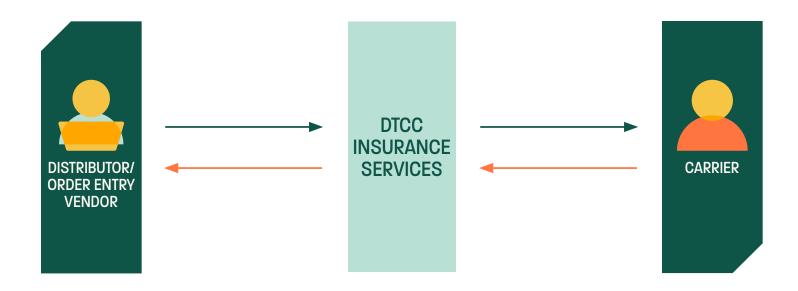
OVERVIEW

Overseeing the statuses of new business can be difficult and inefficient, with many communications existing across multiple mediums, carrier websites and phone calls. DTCC's Insurance & Retirement Services (I&RS) offers a centralized, digitalized method to request status of pending new annuity business with the Activity Status Tracking service (ACT).

By utilizing API messaging, ACT can consistently provide real-time activity status messaging across platforms and planning tools. Carriers and distributors can track full pending books of business, regardless of method of submission (electronic, paper, etc.), throughout the application processing, participating in standardized communication using ACT.

The ACT messaging service will provide oversight, standardized communication, stability and risk reduction, eliminating management of multiple endpoints of connectivity. ACT offers single implementation across all users, providing them with flexible data access options on-demand.

ACT offers a new way for the distributor to keep track of activity status messaging, by requesting statuses for all activity or details of a specific application, ultimately creating operational efficiencies for the industry.
