Producer Management Portal (PMP) is the most comprehensive source available for centralized sharing, tracking and verifying producer training completions. PMP helps insurance carriers and distributors manage and comply with NAIC producer training requirements in a standard web services environment, providing detailed producer training completion information and real-time point-of-sale training authorizations at a low cost.

- Education vendor-sourced course completion details for state training
- Insurance carrier-sourced course completion details for product training
- Insurance carrier-sourced training authorization for annuity sales (based on producer ID, product, state and application date - verifies state and product training)

- Reduce the lead time for obtaining and sharing training completion information, allowing agents to begin selling more quickly and compliantly
