Files for 'FAR to Asset Managers' process

This document describes the record formats for the flat files created from the Insurance Financial Activity Reporting product. These files will be made available on a daily basis for sending to Asset Managers or solution providers on behalf of Asset Managers.

File layout definitions:

- 1. Optional fields that are not used will contain spaces for Alphanumeric or Date fields and zeros/spaces for Numeric fields.
- 2. "Filler" fields will contain spaces.
- 3. Numeric decimal fields are decimal implicit.
- 4. Alphanumeric fields are left justified.
- 5. Numeric fields are right justified with leading zeros.

Column headings are as follows:

- Start: The position where the field starts
- End: The position where the field ends
- Length: The length of the field in bytes
- Type: A/N = Alphanumeric, N = Numeric, D = Date Format (YYYYMMDD)
- Field Name: The name of the field
- Description: Field Usage and Definition
- Allowed Values: Field description
- Item Number: DTCC assigned item number
- Required Indicator: O = Optional, M = Mandatory
