NSCC ECP Proposal - Partial Amend.

Amendment No. 1 to SR-NSCC-2022-005

National Securities Clearing Corporation (“NSCC”) is filing this partial amendment (“Amendment No. 1”) to SR-NSCC-2022-005 (“Proposed Rule Change”), which was filed with the Securities and Exchange Commission on May 20, 2022.

The Proposed Rule Change is proposing to revise the Excess Capital Premium (“ECP”) charge by enhancing the methodology for calculating the charge and improve the transparency of the NSCC Rules & Procedures regarding the ECP charge, as described therein.

In describing the proposed amendment to the Proposed Rule Change below, NSCC has marked **bold, underlined, yellow highlighted text** to represent additional language proposed to be added by this Amendment No. 1.

Please replace the text on page 118 of the Proposed Rule Change with the following text:

Volatility Charge

The term “Volatility Charge” means, in respect to a Member, the portion of its Required Fund Deposit calculated by the Corporation by applying Sections I.(A)(1)(a)(i) – (iii) and (2)(a)(i)-(iii) of Procedure XV.
