DTCC plans to change the record layouts for the Cost Basis Reporting Service (CBRS), to make improvements to the system based on customer feedback.

**CBRS user testing is scheduled to begin on June 22, 2012.** At that time, testing for the existing record layouts will no longer be supported. **These changes are scheduled to go into production on July 27, 2012.**

This Notice describes the various changes to the record layouts. These changes apply to data input and output via the automated mainframe connection, as well as to WebDirect screens and the Upload template. Please review the list of changes below to determine how they will affect your CBRS programming.

**Specifics of the Changes to the Record Layouts**

Fields on the Asset Input, Tax Lot Input, and Cost Basis Transaction MRO record layouts will change. The following table details the changes. After each name in the **Field** column, there is a code indicating which record layout contains the field: **A** = Asset Input, **T** = Tax Lot Input, **O** = Cost Basis Transaction MRO record layout.
