Mediaset S.p.A. (OTC: MDIUY) has announced a 0.02 € cash dividend per ordinary share with regard to the dividend fiscal year 2014. J.P. Morgan Chase Bank acts as Depositary for the company's American Depositary Receipt ("ADR") program.

On ADR Pay Date, all holders will receive this dividend net of the full Italian statutory withholding tax rate of **26%**.

Subsequent to the payment date on which the dividend less the 26% withholding tax will be paid, beneficial owners may reclaim the difference between the statutory rate and the beneficial owner's rate of entitlement by submitting the required documentation to J.P. Morgan Chase Bank "J.P. Morgan". There will be four documentation deadlines set within the time frame of four months from record date. J.P. Morgan will convert the refunds to USD at the prevailing exchange rate on the day the refund is received.
