AND 5:30 P.M., NEW YORK CITY TIME AND UNTIL THE PARTICIPANT'S ACCOUNT WITH DTC IS SETTLED AND IN BALANCE.

- A. <u>Deposits</u>: Continuous Net Settlement (CNS) Deposits received in the night drop on Friday, May 22, 2015 will be available for credit toward CNS settlement obligations of Tuesday, May 26, 2015. **DTC** will not provide record date protection on deposits made in the night drop of Friday, May 22, 2015.
- B. DTC Night Delivery Orders (NDO) should be submitted on Friday, May 22, 2015 for processing and settlement on Tuesday, May 26, 2015.
- C. Requests for Withdrawal-by-Transfer (WT): To avoid dividend problems, you are reminded to exclude any securities that have a record date of Monday, May 25, 2015 from your submissions of WT made by PTS on Thursday, May 21, 2015 or by CCF prior to the 8:30 A.M. cut-off on Friday, May 22, 2015.
- D. The Participant Browser Services (PBS), the Participant Terminal System (PTS) and the Settlement Web (SW) will be available on Monday, May 25, 2015 for limited processing.
- E. <u>Canadian Dollar Link:</u> **DTC will be open on Monday, May 25, 2015 to process and settle transactions submitted via the Canadian Dollar Settlement Link.**
