The National Securities Clearing Corporation (NSCC) will commence with the Consolidated Trade Summary (CTS), Member UAT Testing in preparation for the new file formats launch planned for June 23, 2017, subject to the Securities and Exchange Commission (SEC) approval.

NSCC Important Notice # A8295, dated November 11, 2016 defines UAT Member testing opportunities and how to utilize the available output from testing regions: (PSE U, PSE A and the Clearing Dashboard.)

As part of the NSCC Member UAT testing of the CTS, an unexpected close event has been scheduled for Thursday January 5, 2017 in the PSE U test region. The unexpected close event will consist of trading being open and U. S. settlement closed. The unexpected close exercise will provide the opportunity for Members to know what data is produced on each of the three CTS cycles. Submissions for a T+3 scenario would be input on December 30, 2016 (trade date) for January 6, 2017 (settlement date.) The following chart shows the reporting of trades on the CTS.

### Subscribing to CTS files

The new AutoRoute files are available in either the machine readable output (MRO) or comma separated values (CSV) formats. When subscribing for the new CTS file, NSCC Members will need to specify their IP address, node name, and note what PSE testing regions will be connected as the new CTS output will be available in both.
