The Cost Basis Reporting Service (CBRS) is preparing participant testing to support the changes on the Tax Lot Input Record to further support the transfer of cost basis.

The adjustments to the CBRS Tax Lot Input and Output layouts were specified in the DTCC Solutions, LLC Important Notice: CBRS006.2015, dated December 17, 2015. In order to prepare for the June 2016 deployment into production, firms should test both their input and output.

- Test with DTCC by submitting CBRS input and receiving output starting May 23, 2016.
- Implement procedures or software internally to coincide with the first production date in CBRS on June 24, 2016.

<u>Testing</u>

The Participant Services Environment (PSE) CBRS system will accept and edit files according to the definitions on the new record layout beginning May 23, 2016. DTCC Web Direct input will also be available.

If a firm submits cost basis records and CBRS accepts the data, then output will be generated during the end of day process. Below is a list of the relevant files.
