Subject:	CBRS Statistical Reports Production	

DTCC plans to offer new statistical reports for Cost Basis Reporting Service (CBRS) users that will provide firms with more visibility into their CBRS transactions usage. The reports being offered were a result of a collaborative industry effort. The reports will be provided to firms via file transmissions or available to download via the CBRS Web Portal. Firms wishing to consume these new reports will need to subscribe to the new AutoRoute output product IDs. This release includes only AutoRoute output consumption of the reports. **DTCC will make these reports available on the CBRS Web Portal in a future release.** Further instructions are outlined below.

## **Statistical Reports**

Starting October 19, 2018, firms will be able to subscribe to the new CBRS Statistical Reports "CBI Stats MTD Submitter of Assets" & "CBI Stats MTD Receiver of Assets" in DTCC's Participant Service Environment (PSE) test region. Production is scheduled for November 16, 2018 with the first report being made available December 3, 2018. There is no file specification for these reports as they are readable statistical reports. These reports will be provided on the first processing day of the month and will reflect last month's volume. Firms will need to submit test transactions to view the statistical information in the PSE region. These reports will provide clients with a breakdown of submissions and receives at an asset level broken down my transaction type. The reports will also provide the same information for the entire CBRS community to provide clients with visibility as to how their submission and receive volume compares to the industry.

## **Testing**

Firms will be able to submit test transactions in the PSE region starting October 19, 2018 and view daily statistical information the following processing day. Daily statistical output will only be available in PSE for testing purposes. Firms must submit in the PSE region using Test Product ID 46708.

## Registration

Subscription to the new CBRS Statistical Reports will require firms to update their existing CBRS Product Request Form. Firms will need to subscribe to both the Submitter and Receiver report to receive both outputs highlighted below. For this implementation the statistical reports will only be available for AutoRoute output. DTCC will make these reports available on the CBRS Web Portal in a future release.
