As previously announced via Important Notice #[A8530](#), NSCC is redesigning and improving its CMU RTTM Web system. As part of this effort and prior to the new web screens going into production, we will be requiring firms that access CMU RTTM Web to test on a mandatory basis.

New CMU RTTM Web is expected to go into Production at the end of Q3 2018 with the exact date to be announced in subsequent Important Notices.

Enhanced Browser Option

One of the enhancements of new CMU RTTM Web is to allow users to access the application using Google Chrome version 58 or higher, in addition to IE 11. Although both browsers offer the same capabilities and functionality, Google Chrome provides for a more enhanced user experience. It is recommended users experiment with both and utilize the browser that better fits their needs.

Mandatory Participant Testing

The mandatory testing period is tentatively scheduled to run from July 2nd through September 14th. However, access to view the new screens will be available via the DTCC's Participant Services test Environment (PSE) on June 6th.

As we get closer to the mandatory testing period, we will be issuing instructions on what firms need to do to coordinate this effort with our testing team. (Test scripts will be provided.)

Training

Training of new CMU RTTM screens will be made available in the form of Webcasts and Webinars to firms. We anticipate posting a webcast on the DTCC Learning site in early July. The webcast will give firms an opportunity to become more familiar with the screens and also provide guidance with completing the mandatory testing. Firms will be able to view the webcast at their leisure.

In addition to the webcast, we also plan to host live Webinars starting in late July through early September; the exact dates will be provided at a later time. Lastly, a new User Guide will also be produced and made available to firms.

Participants Need to Ensure Access to CMU RTTM PSE Test Region

CMU Web Operators need to ensure they are able to access the CMU RTTM PSE test region as testing will be mandatory. DTCC has commenced an outreach to Participants via email asking firms to check access to the test region. If you have not received an email on this regards, please contact the undersigned.
