Effective March 11, 2020, the **monthly** schedule for the National Securities Clearing Corporation (NSCC)'s Obligation Warehouse (OW) process known as the Reconfirmation and Pricing Service (RECAPS) will no longer be published. The 2020 schedule was announced in the Important Notice A# 8768, dated November 1, 2019. The remaining 2020 dates for OW RECAPS are set forth in the table below. Additionally, the RECAPS schedule can be found on the home screen of Obligation Warehouse.

If the schedule changes on an ad-hoc basis, an Important Notice will be published reflecting any changes.
