On March 26, 2020, Fixed Income Clearing Corporation (“FICC”) filed a filed proposed rule change (SR-FICC-2020-003) (“Rule Filing”) with the Securities and Exchange Commission (“SEC”) proposing to amend the Clearing Agency Investment Policy.
